## Summer Camp Registration Form Terms

This "Summer Camp Registration" is entered into by and between Music Masters, LLC, an Oregon LLC, (hereinafter: "Music Masters"), and the parent(s) or guardian(s) whose signatures appear below. The parties hereto accept the following terms and conditions governing the camper's enrollment at Music Masters. I/we understand that it is a temporary enrollment contract. My camper's enrollment at Music Masters shall be only during the camps chosen. I further understand that if I have multiple campers, each camper must have their own contract filled out in full.

Tuition rates for each one-week session includes all material costs. Lunch and snacks must be provided by the family.

Full Summer Camp Payment is due with the Registration Form. Any cancellations must be made greater than 14 days before the first day of the camp being cancelled. Cancellations less than 14 days before camp start are not eligible for a refund. If Music Masters needs to cancel a camp for any reason, you will be offered a full refund.

## Medical Release Form and Emergency Procedures

### Emergency Medical Release

If medical care is deemed necessary and I cannot be contacted, I authorize Music Masters staff to act on my behalf in deciding the proper course of action for my camper. This includes but is not limited to permission for Music Masters to render any emergency medical treatment that Music Masters staff deem appropriate and/or necessary for the well-being of my camper, including, but not limited to First Aid, CPR, calling emergency ambulance transportation and hospitalization, if necessary.

I understand and agree that any and all actions taken by Music Masters for the benefit of my camper comes at my cost, including but not limited to, emergency medical treatment or care and ambulance transportation. I promise to hold Music Masters harmless and indemnify Music

Masters for any and all costs associated with any medical treatment it has deemed necessary and/or appropriate for the well-being of my camper, including, but not limited to, any and all costs associated with emergency room visits, hospital care, and ambulance services.

I specifically release Music Masters from any and all claims, loss, costs, damage, or expenses arising out of or from the exercise of their discretion in seeking medical treatment on behalf of my camper as Music Masters may deem necessary and/or appropriate, and also release Music Masters from any and all claims, losses, costs, damages, and/or expenses associated with any negligent treatment or medical malpractice committed by any medical professional, which I might otherwise pursue against Music Masters in whole or part, including joint or several liability.

### **Code of Conduct**

### **Media Consent**

I hereby grant permission for Music Masters and any third party partners to take photographs, video, and audio of my child in connection with camp activities and the final performance. Any photographs, video, or audio taken may be used for public view, including but not limited to television, radio, print media, and internet websites.

I understand and agree that neither I nor my camper will receive any financial remuneration in connection with any interviews, photographs, video recordings, or audio recordings of my camper. I understand and agree to release Music Masters from any future claims for injury, loss or damage of any kind associated with or arising from the use of said photographs, interviews, video recordings, or audio recordings.

I agree not to hold Music Masters responsible for the actions of any third parties in connection with any interviews, photographs, video recordings, and/or audio recordings taken of my camper, including news media organizations.

### **Legal Terms**

1. Entire Agreement and Binding Effect. This Agreement, along with the other documents referred to herein, is the final integration of the agreement between the parties with respect to the matters covered by it and supersedes any prior understandings or agreements, oral or written, with respect thereto. The provisions of this Agreement shall inure to the benefit of, and be binding on, the parties and their successors, assigns, employees, legal representatives, heirs, distributes, and transferees.

2. Governing Law, Jurisdiction and Venue. This Agreement shall be governed by and construed in accordance with the laws of the State of Oregon applicable to contracts to be performed solely within such state. The District Court of the City and County of Lane, State of Oregon, shall have exclusive jurisdiction, including in personal, jurisdiction, and shall be the exclusive venue for any and all controversies and claims arising out of or relating to this Agreement.
3. Modification, Waiver and Severability. This Agreement may not be modified or supplemented except by written instrument signed by the parties. No waiver of any default or breach of any agreement or provision herein contained shall be deemed a waiver of any other default or breach thereof or of any other agreement or provision herein contained. If any provision or portion of a provision of this Agreement is declared void and/or unenforceable, such provision or portion shall be deemed severed from this Agreement, which shall otherwise remain in full force and effect.
4. Attorneys' Fees and Costs. In the event any suit or other action is commenced to construe or enforce any provision of this Agreement, the prevailing party shall be awarded reasonable attorneys' fees and court costs, in addition to all other relief to which such party shall be entitled.
5. Counterparts/Electronic Signatures. This Agreement may be executed in one or more counterparts, all of which taken together shall constitute one instrument. A facsimile or other electronic copy of a signature on this Agreement shall be acceptable as and deemed to be an original signature.
